2. Previous Parish Council meetings

2.1 To approve the minutes of the Ordinary Meeting of 9th April 2024 (circulated as pre-reading)

2.3 Clerk's Report & items actioned since last meeting:

- RJ has made preliminary enquiries with the Diocesan Solicitor regarding rental of Glebe Field for one off events but has not received a detailed response as to whether this would be practicable.
- Chris Cook has taken over from Richard Woodley as clerk of Pillaton, Chris is also clerk for Botus Fleming and Landrake with St. Erney.

3. Questions from the public & correspondence received:

It was noted by residents of Church Lane that the police have recently been active in the Glebe Estate area and Golf Course in pursuit of a perpetrator. No other details are known at present. The population of the parish has increased by one with the birth of a child to the Hammond family, named Reginald Connor Hammond, congratulations were offered and gratefully received.

5. Planning matters (HG and BB left the meeting).

5.1. Planning Applications.

PA24/01887 Louise Evans Woolaton Barn, St Mellion, PL12 6RN. Internal works to Grade II dwelling as well as erection of garage to serve the dwelling. Planning Officer: Ellen Lawrence. Consultation Expiry Date: 7th May 2024 (extension granted to 15th May 2024). Planning Officer: Ellen Lawrence.

PA24/02394 Louise Evans Woolaton Barn, St Mellion, PL12 6RN.

Listed Building Consent: Internal works to Grade II dwelling as well as erection of garage to serve the dwelling.

Planning Officer: Ellen Lawrence.

Consultation Expiry Date: 7th May 2024 (extension granted to 15th May 2024).

The following issues were noted:

- The windows were installed prior to the listed building status being applied and are not sympathetic to the original style of the building.
- Historic Environment (Planning) have commented that the suggested windows in the plan are not approved as they are uPVC and that they should be constructed of natural wood, which the current windows are but which is clearly more expensive to undertake.
- Any change of design or materials for windows will need to be approved.
- There are very minimal details about the garage construction.
- In the application the garage is noted as having rendered walls, which would be out of keeping with the original Cornish stone of the residence.
- It is presumed that the garage will need to have the standard EV point installed at the point of construction.
- The building has been neglected and is worthy or preservation, so it is good to see that it is being brought back to life as a family home.

It was proposed by BK, seconded by PS and RESOLVED to support the applications PA24/01887 and PA24/02394, all in favour.

6. Highway & Transport

6.1. Church Lane & Speedwatch:

The Traffic report from CORMAC for 18th April to 25th April 2024 was shown on screen and shared as prereading.

It was noted that:

- The 20mph speed limit is being observed for the most part.
- The numbers of cars using Church Lane to get to the Golf Club end is three times as many as are going towards the church, which is thought to be because turning right at the A388 end is quite dangerous.
- The numbers reduce significantly at the weekend, which reflects the school run traffic using it during the week.
- The useful time stamp information can help infer what type of user is accessing the Golf Club for recreation or employment.

6.2. Any other issues to note: Road Traffic Regulation Act 1984 S.14: Temporary Prohibition of Traffic Location: Saltash Road, A388 between Vernigo Roundabout and Westcott Lodge, A388 between the Glebe and Vernigo Roundabout, A388 between Paynters Cross and The Glebe, Callington. Timing: 28th May 2024 to 1st June 2024 (19:00 to 06:00 hours).

7. Council Property & Assets

7.1. Approval of tender process for tree survey at Jubilee Bus Stop:

BK has reported that there is an electrical fault in the heating pad for the defibrillator in the phone box, an electrician has been notified and expenditure in relation to fixing the fault will be reviewed at the next meeting.

RJ has sought advice from Cornwall Council Highways department about how best to accomplish a tree survey and to confirm that this is the landowner's responsibility. They have helpfully provided a link to the Institute of Chartered Foresters Directory. Three qualified consultants have been approached for quotes and the results will be reviewed at the next meeting.

St. Mellion Parish on the condition that any activities or services they provide are used by parishioners of St. Mellion.
